AN EXECUTIVE ORDER CREATING THE MUNICIPAL TRAFFIC MANAGEMENT BOARD OF THE MUNICIPALITY OF DUPAX DEL NORTE

WHEREAS, the Municipality of Dupax del Norte is located at a strategic location in the southern part of Nueva Vizcaya being the passage of three major routes, the Dupax del Norte - Dupax del Sur route via the interior highway, Dupax del Norte - Dupax del Sur - Aritao route via the northern highway and Dupax del Norte - Dupax del Sur route via the southern highway;

WHEREAS, given this strategic location that Dupax del Norte has, it is observed that an increasing volume of traffic is experienced every year that put the lives of our constituents particularly motorcycle riders at risk if there is no traffic management body that would be responsible in monitoring the implementation of the Municipal Traffic Code;

WHEREAS, this body shall serve as a consultative and advisory body of the Municipal Mayor and the Sangguninag Bayan particularly the SB Committee on Transportation and Public Utilities in matters pertaining to traffic operation management of the Municipality of Dupax del Norte;

NOW, THEREFORE, I, TIMOTHY JOSEPH E. CAYTON, Municipal Mayor of Dupax del Norte, by virtue of the powers and authority vested in me by law, do hereby create the Municipal Traffic Management Board of the Municipality of Dupax del Norte.

Section 1. COMPOSITION

There shall be created a Municipal Traffic Management Board that will be composed of the following:

Section 2. FUNCTIONS AND DUTIES OF THE MUNICIPAL TRAFFIC MANAGEMENT BOARD.

1. Conducts periodic review of the implementation of the Municipal Traffic Code as well as the reports and the recommendation submitted by the Municipal Traffic Management Office;
2. Evaluates the effectiveness of the traffic management schemes being implemented by the Municipal Government;
3. Reviews the efficiency and effectiveness of the implementation of the Municipal Traffic Code and other rules and regulations by the Municipal Traffic Management Office; and
4. Serves as consultative and advisory body of the Municipal Mayor and the Sangguniang Bayan Committee on Transportation and Public Utilities in matters pertaining to traffic operation management in the Municipality of Dupax del Norte.

Section 3. EFFECTIVITY

This Order takes effect immediately.
