



**EXECUTIVE ORDER NO. 34
Series of 2020**

AN ORDER CREATING THE MUNICIPAL EVALUATION TEAM (MET) FOR THE SEARCH OF "IDOL KONG PAMILYA (IKP) 2020", "IDOL KONG ENTREPRENUER", AND MOST CHILD-FRIENDLY BARANGAY TO EVALUATE AND IDENTIFY QUALIFIED ENTRIES BASED FROM THE RESULTS OF THE BARANGAY LEVEL EVALUATION WHO WILL PARTICIPATE AND REPRESENT THE MUNICIPALITY OF DUPAX DEL NORTE IN THE SAID PROGRAMS

WHEREAS, Barangay entries that were validated by the Barangay Evaluation Team through their Barangay Council for the Protection of Children (BCPC) shall be submitted to the LCPC/MSWDO;

WHEREAS, through the Local Council for the Protection of Children (LCPC), the Municipal Evaluation Team (MET) shall validate all qualified Barangay entries for the Search of "Idol kong Pamilya (IKP) 2020", "Idol Kong Entrepreneur", and the Most Child-friendly Barangay;

WHEREAS, the top three (3) entries shall be identified by the Municipal Evaluation Team (MET) through the Local Council for the Protection of Children (LCPC) after all qualified barangay entries are validated/evaluated;

WHEREAS, the creation of the Municipal Evaluation Team (MET) through the Local Council for the Protection of Children (LCPC) is indispensable in order to evaluate and identify qualified entries for the Search of "Idol Kong Pamilya (IKP) 2020", "Idol Kong Entrepreneur", and the Most Child-friendly Barangay;

NOW THEREFORE, I, TIMOTHY JOSPEH E. CAYTON, Municipal Mayor of Dupax del Norte, Nueva Vizcaya, by virtue of the authority vested in me by law, do hereby order the following:

SECTION 1. Composition

SECTION 2. Responsibilities

1. Assist the Barangay Evaluation Team for necessary and relevant concerns in the evaluation process.
2. Accept, evaluate, and identify qualified entries which will be submitted by the Barangay Councils.
3. Select the top three (3) entries based from the evaluation process who will represent the Municipality of Dupax del Norte in the said programs.

All Barangay Councils and concerned personnel are required to coordinate with the team and provide information updates which are necessary for the evaluation and identification of qualified entries.

SECTION 3. Effectivity

This order shall take effect immediately.
