AN EXECUTIVE ORDER RECONSTITUTING THE DUPAX DEL NORTE PUBLIC MARKET COMMITTEE

WHEREAS, the new mandate of the People of Dupax del Norte had been bestowed upon the present administration through the recently concluded local elections;

WHEREAS, with such new mandate, there is a need for the present administration to create the composition of the Dupax del Norte Public Market Committee to continue and improve the delivery of basic services by the Municipality to its constituents through the Municipal Public Market;

WHEREAS, due to the end of term of office or retirement of the former members, the reconstitution of the Bids and Awards Committee (BAC) is required;

NOW THEREFORE, I, ATTY. TIMOTHY JOSEPH E. CAYTON, Municipal Mayor of Dupax del Norte, Nueva Vizcaya, by virtue to the power vested in me by law and the sovereign will of the people, do hereby order:

SECTION 1. COMPOSITION. The task force shall be composed of the following:

SECTION 2. ROLES AND FUNCTIONS OF THE MUNICIPAL PUBLIC MARKET COMMITTEE:

1. Adjudication of vacant or newly constructed market stalls
2. Conduct drawing of lots
3. Formulate rules and regulations for the efficient operation of the Public Market
4. To carry out the purpose of the Market Code

SECTION 3. REPEALING CLAUSE.

All issuances, orders, rules and regulations, or parts thereof that are inconsistent with any provision of this Order are hereby repealed or modified accordingly.

SECTION 4. SEPARABILITY CLAUSE.

If any provisions or part hereof is held invalid or unconstitutional, the remainder of this Order not otherwise affected shall remain in full force and effect.

SECTION 5. EFFECTIVITY.

This Executive Order shall take effect immediately.
