Series of 2020**

**AN ORDER RECONSTITUTING THE MUNICIPAL TASK FORCE TO CLEAR
ROADS OF ILLEGAL STRUCTURES AND CONSTRUCTION IN THE
MUNICIPALITY OF DUPAX DEL NORTE, NUEVA VIZCAYA**

WHEREAS, Section 32 of the Local Government Code states that “The city or Municipality, through the city or Municipal Government Concerned, shall exercise general supervision over component Barangays to ensure the said Barangays act within the scope of their prescribed powers and functions.”;

WHEREAS, in line with the Presidential Directive during the 2019 State of the Nation Address, all Local Officials are enjoined to exercise their powers essential to reclaim public roads which are being used for private ends and in the process, rid them of illegal structures and constructions;

WHEREAS, Local Chief Executives are directed to revoke permits that give authority to private entities to occupy public roads, alleys and other thoroughfares;

NOW THEREFORE, I Atty. TIMOTHY JOSEPH E. CAYTON, by the power vested in me by law do hereby order and direct the following:

Section 1. Composition – The Municipal Task Force to Clear Roads of Illegal Structures and Construction is further organized as follow:

Section 2 Roles and Functions of the Task Force

- a) Ensure effective implementation of the Presidential Directive consistent with related laws and policies.
- b) Prepare an inventory of all roads within the territorial jurisdiction of the Municipality
- c) Revisit ordinances and similar legislative measures to ensure responsiveness to the Presidential directive.
- d) Ensure immediate and effective implementation of road clearing operations.
- e) Within sixty (60) calendar days, significant results must be achieved, documented, and reported together with the efforts of the LGU to sustain the same.
- f) Submit a weekly progress report on this matter to the office of the DILG Provincial Director thru the MLGOO.
- g) Perform all other functions assigned by law

Section 3. Secretariat – The Secretariat shall come from the regular Staff of the Task Force Chairman.

Section 4. Effectivity - This Order Shall take effect immediately.
